The Centre houses 44 meeting and event spaces, four exhibition halls, restaurant facilities and a number of food and beverage outlets.</p> <p><b>Risk Impacts</b>          With 1300 events and an average of 700,000 people passing through the Centre on an annual basis, BCEC is a major enterprise and its operation results in the consumption of significant quantities of energy and resources.
